Section 6: Terms and Conditions

- The Dispatch Operator licence is granted for a period of 12 months.
- Bookings shall only be provided to a driver where that driver holds a valid SPSV driver licence and is operating a licensed vehicle carrying SPSV insurance.
- Upon request, a Dispatch Operator shall provide the NTA with contact information for all drivers affiliated to it for the purposes of making and receiving bookings.
- Upon request, a Dispatch Operator shall provide the NTA with a complete list of all current vehicles and drivers affiliated with it.
- A Dispatch Operator shall maintain a consumer complaints procedure to effectively address complaints received from users. This information must be provided to the NTA upon request.
- A Dispatch Operator shall implement a record management system to record all bookings and complaints received. This information must be provided to the NTA upon request.
- The Dispatch Operator is responsible for notifying the NTA of any change of name or address, including a change to any trading name, within 14 days of such change.
- The National Transport Authority will use the information provided for the purpose of administering the SPSV licensing system and in order to perform the functions assigned to it by the Taxi Regulation Act 2013, including the maintenance of a public register of SPSVs. Information provided will be shared with certain authorised third parties where necessary in order to carry out our functions and for the purposes of law enforcement. The National Transport Authority is registered with the Office of the Data Protection Commissioner and all information sharing will be performed in accordance with the Data Protection Acts 1988 and 2003.
- The operation of a Dispatch Operator licence is subject to the provisions of the Taxi Regulation Acts 2013 and 2016, Road Traffic Acts 1961 to date and any regulations made thereunder.
- I grant the National Transport Authority permission to verify my tax clearance status with Revenue.
- The fee of €100 shall be paid in full.

Section 7: Declaration
